

**ADDENDUM**  
**to the**  
**MEMORANDUM OF UNDERSTANDING**  
between  
the Ministry for the Environment, Land and Sea of Italy  
and  
the Governments of Antigua and Barbuda, the Bahamas, Belize, Dominica, Grenada,  
Guyana, Haiti, Saint Kitts and Nevis, Saint Lucia, and Saint Vincent and the  
Grenadines  
on  
**CO-OPERATION ON CLIMATE CHANGE**  
**VULNERABILITY, ADAPTATION AND MITIGATION**

WHEREAS the Governments of Antigua and Barbuda, the Bahamas, Belize, Dominica, Grenada, Guyana, Haiti, Saint Kitts and Nevis, Saint Lucia, Saint Vincent and the Grenadines, and the Italian Ministry for the Environment, Land and Sea (IMELS), hereafter referred to as “the Signatories”, have signed a Memorandum of Understanding on cooperation in the field of climate change vulnerability, adaptation and mitigation, hereafter referred to as “the Memorandum”;

WHEREAS the Signatories wish to add to the Memorandum a provision to extend the contribution of the Ministry of Environment, Land and Sea for the implementation of projects and activities under the Memorandum to the period 2018 - 2019;

WHEREAS Article 5 “Final Provisions” of the MOU provides that the Parties may amend the MOU by a written agreement signed by the Signatories;

NOW, THEREFORE, in consideration of the foregoing, the Signatories agree as follows:

1. A new paragraph 3.b. of Article 2 is introduced to read:

“3. The Italian Ministry for the Environment, Land and Sea shall:

...

b. Co-finance the implementation of the projects under this Memorandum in accordance with the Programme outline contained in the annexes, through direct contributions or through a designated implementing agency, for an amount not exceeding 6 (six) million euros, in the period 2018-2019. “

2. All other terms, provisions and conditions stipulated in the Memorandum remain unchanged.

3. This Addendum becomes effective on the date of its signature and shall be integral part of the Memorandum.
