**Re.: Contribution from the Government of Italy acting through the Ministry of Environment and Energy Security (the “Donor”) to the Amazon Bioeconomy and Forest Management Fund (the “Fund”)**

Dear Mr. Bendersky:

I am pleased to inform the Inter-American Development Bank (the “IDB” or the “Bank”, and together with the Donor, the “Parties”) of the decision of the Donor to accept the Terms and Conditions of the Fund dated as of November 23, 2021 (the “Terms and Conditions”), as may be amended or otherwise modified from time to time, and, as further detailed herein, to contribute to the Fund the amount of EUR5,000,000.00 (five million euros) (the “Contribution”), subject to the terms of this Contribution Letter.

1. The Contribution will be payable to the IDB in one single installment, upon written request from the IDB and in accordance with the following payment schedule:

Letter by the Donor and the Bank:

EUR5,000,000.00 (five million euros)

2. Upon the Bank’s receipt of the Contribution, the Bank will convert the euros into United States dollars and will deposit the resulting amount (subject to the exchange rate prevailing at the time of conversion) into the Fund account, where it will be held together with Contributions from other Donors.
3. The Donor agrees that the Terms and Conditions (attached hereto as “Annex A”) will apply to the Contribution. The IDB will administer the Contribution in accordance with the Terms and Conditions.
4. The Contribution will be subject to the Administrative Fee established in Article 3, Section 7 of the Terms and Conditions.
5. Capitalized terms used but not defined in this Contribution Letter will have the meaning ascribed to them in the Terms and Conditions.


