

## BACKGROUND DESIGN ANALYSIS

### **Baseline scenario:**

The promotion of low carbon technology deployment and strong networks for SMEs, startups and entrepreneurs, has the potential to contribute to the mitigation/adaptation to the climate change, while also simultaneously strengthening the comparative advantage and competitiveness of the industrial sector in developing economies such as Iran.

This networking approach will help in contributing to job creation, improved living standards and the development of sustainable and inclusive regional and global value chains in a perspective of a win-win cooperation through agreements and international partnerships with Italian stakeholders and technology providers in these industrial sectors.

This project responds to an increasing demand for innovative partnerships, multi-level and integrated solutions to address the energy, climate and development challenges simultaneously, providing an innovative tool to cover the gap in the nexus between energy, food and water issues.

In addition the project will contribute particularly to the cross-cutting area of Sustainable Development Goal (SDG) 7 on Sustainable Energy and SDG 9 on sustainable industrial development, pursuing the objectives and commitments undertaken at COP 21 in Paris.

### **Institutional arrangements and coordination mechanism:**

The leading goal of the project is to support the Iranian Government in upgrading and strengthening the competitiveness of the industrial SMEs in Iran by identifying and promoting sustainable investment and technology transfer opportunities in selected environment and renewable energy sectors with the aim of supporting sustainable development, local job creation and fostering international partnerships, ensuring an Inclusive and Sustainable Development to be attained in collaboration with Central and Local Administrations and Regional Authorities, under the strategic vision of the Italian Ministry for the Environment, Land and Sea.

The technical competences to be developed locally, supported by research, training and knowledge diffusion, allow the stakeholders involved in the project to apply advanced models of interventions through an integrated approach to the development themes such as technologies, management, means, actions, information, etc...

The project will focus on specific tailored services to foster international partnerships on the basis of the high relevance for leveraging investments in energy and environment services, infrastructure, local businesses and industry.

Investment and business promotion will be an important activity component of the project' activities but also a cross-cutting issue across the other components capacity development, expected spill-over effects of the different interventions; for example awareness raising and capacity building can lead to positive developments in the area of policy formulation and investment promotion.

In implementing its activities, UNIDO ITPO Italy will, whenever possible, work with already existing institutions in Iran so as to build already existing capacities but also to promote collaboration between such institutions. The support offered to the Local Authorities will help them in becoming leaders of their own territorial development, inducing a more responsible use of available resources and, finally, gaining an

improved awareness and a more qualified opinion and perception of their own territory, boosting its capacity to attract investments and wealth.

Cooperation with a wide range of public/private and local/international stakeholders during implementation will maximize the local added value, north-south and south-south technology and know-how transfer to Iran. This also prevents unnecessary duplication of effort and competition with already existing national energy institutions and companies. In addition, this approach maximizes the impact and visibility of the project' activities in the region.

The importance of a coordinated approach is highlighted, and the need for UNIDO ITPO Italy to work closely with Member State ministries and agencies responsible for energy and environment, particularly through the selected National Focal Institutions as the main contact point, also in order to improve competitiveness of local institutional and private counterparts and aligning with the undertaken commitments in COP 21.

#### **Funding strategy and Disbursement:**

The total contribution of € 99.750 (including support costs) will be covered by the donor, Italian Ministry for the Environment, Land and Sea in three installments.

The first installment of 60% of the total amount will be made against a written request by UNIDO ITPO Italy to the Italian Ministry for the Environment, Land and Sea, upon the approval of the project.

The second installment of 30% of the total amount will be made after receipt of a written request by UNIDO ITPO Italy to the Italian Ministry for the Environment, Land and Sea and a progress technical and financial report on the use of the previous payment.

A third installment of 10% of the total amount will be made after receipt of a written request by UNIDO ITPO Italy to the Italian Ministry for the Environment, Land and Sea, and a final technical and financial report.

All financial accounts and statements shall be expressed in Euro.

UNIDO ITPO Italy shall furnish to the Italian Ministry for the Environment, Land and Sea with a progress technical and financial report and a final technical and financial report, including financial supporting documents, in accordance with the UNIDO rules, on the activities and the main achievements of the project. The project will be monitored also according to the indicators listed by the Italian Minister for the Environment, Land and Sea, if any.

## **RESULT ORIENTED PROJECT DESIGN : LOGIC OF INTERVENTION**

### **Project Objective:**

The objective of the project is to support the Iranian Government in upgrading and strengthening the competitiveness of the industrial SMEs in Iran by identifying and promoting sustainable investment and technology transfer opportunities in selected environment and renewable energy sectors with the aim of supporting sustainable development, local job creation and fostering international partnerships.

To pursue this goal UNIDO ITPO Italy, in synergy with the Italian Ministry for the Environment, Land and Sea and on the basis of its previous successful experiences concerning these activities, will establish and operate a focal point in Iran that will assist in field UNIDO ITPO Italy in scouting an ad hoc portfolio of sustainable investment opportunities in the country and open up new international partnerships, working also in close cooperation with other local institutions in supporting private sector.

UNIDO will act as an honest broker in the identification and formulation of investment projects for local companies and to promote them within the UNIDO ITPO Italy network and in the international business community in order to support new investments in the country and open opportunities for technological upgrading of the local companies in the sector.

In respecting other activities in the energy and environment sectors the actions will be closely coordinated with on-going sectorial activities implemented by UNIDO and other organizations in order to achieve synergies and avoid overlapping.

According to information spreading within the UNIDO network, it is envisaged that neighboring countries could take advantage of the project lessons learned, paving the way for future similar synergies developed in a collaboration framework between the Italian Ministry for the Environment, Land and Sea and UNIDO ITPO Italy.

### **Inception Phase**

During the inception phase UNIDO ITPO Italy will carry out the following activities:

- Establishment of the focal point and selection/recruitment of the 2 local staff (1 technician and 1 business developer/institutional relations manager – with expertise in Procurement)
- Consultations with selected local stakeholders in Iran to refine the design of the project and finalize the activity plan, including the targets to benefit during the development of the project and the expected results to be achieved on the basis of the first appraisal
- Announcement and communication campaign to be carried out to inform all relevant stakeholders about the establishment of the services, at

State, national and international levels (including through ITPO Network and UNIDO field offices). This will include contacting women's and youth entrepreneurship groups and networks

- On-the job training in UNIDO methodologies (also on the basis of the goals expressed by the Donor) for the national focal point and other stakeholders
- Identification and mapping of promising sectors/clusters/value chains in the country and conduct analysis on policy framework to identify potential bottlenecks and remedial actions

## Activities and Outputs

The project's activities will be coordinated under the guidance of UNIDO ITPO Italy and in line with the strategic view of the Italian Ministry for the Environment, Land and Sea and the local Governmental strategies and activities.

Following project activities, assisted SMEs will be strengthened and geared to local, national and international markets.

The project would focus the largest part of its resources to promote investments opportunities and technology transfer in Iran, mainly in collaboration with Italy, more precisely by supporting its SMEs and local public officers related to investment promotion with trade fairs, country presentations, training and direct business-matching

SMEs owned and/or managed by women and youth shall be particularly targeted and paid special attention to throughout the intervention.

The main activities to be carried out within this project are:

- Identified a number of concrete investment opportunities in the country in the selected sectors;
  - Promoted the selected opportunities to the investors and technology providers in the ITPO Italy network creating a successful matchmaking with the local counterparts with the aim to contribute in increasing the total value of the trade and investment ongoing agreements in the country;
  - Disseminated knowledge to local industrial SMEs concerning new sustainable technologies in the selected sectors;
  - Improved local investment officer's skills in identifying & promoting internationally investment projects in order to build a long-lasting reliable network in the country.
  - Supported the promotion of investment and trade agreements between local SMEs and international actors, mainly from Italy.

  - Demonstrated technical viability of innovative technologies on the sustainable energy and climate change adaptation
