Time to Adapt - Climate Change Escape Room

By Italian Red Cross (Associazione della Croce Rossa Italiana)

Presentation of Italian Red Cross activities on climate change and disaster risk reduction. The presentation will be followed by an interactive activity, the Escape Room game. The participants (15 participants for each 30-minute round) will be invited to identify with the members of an imaginary community, called to work for the adaptation of their territory to climate change. Through quizzes and puzzles, they will be guided through the evaluation of all the necessary steps to make their communities more resilient. The Escape game "Time to adapt" is based on the indications of the second part of the IPCC Sixth Assessment Report "Climate Change 2022: Impacts, Adaptation and Vulnerability" and on the experience of the Italian Red Cross and of the International Federation of the Red Cross and Red Crescent Societies in preparing communities to face the climate crisis. The game, as an immersive educational tool, recreates the main conditions of vulnerability experienced by the territories most exposed to the climate crisis. It stimulates reflection on individual and collective actions and decisions which should be taken to avoid being unprepared to the consequences of climate change.
